This was disclosed in the prospectus registered with the Monetary of Singapore in relation to the initial public offering of the shares by the issuer. This notification is in respect of the deemed interest of the Economic Development Board ("EDB"), through EDBI in the 82,056,676 issuer shares collectively held by PLEI and MCV by virtue of section 7(4) of the Companies Act as EDBI holds a controlling interest in PLEI and MCV, and EDB holds 100% of EDBI. This delayed notification which was to have been given within 2 business days of the listing date (i.e. 14 March 2003)

was inadvertent and an honest omission, and not any attempt to conceal the deemed interest of EDB.
