The change in the percentage level is the result is a transaction. This notification is in respect of the deemed interest of the Economic Development Board ("EDB"), through EDB Investments Pte Ltd ("EDBI") in the issuer shares collectively held by PLEI and MCV by virtue of section 7(4) of the Companies Act as EDBI holds a controlling interest in PLEI and MCV, and EDB holds 100% of EDBI. EDB is also deemed interested in the said issuer shares through EDBI's wholly-owned subsidiary, EDBV Management Pte. Ltd. ("EDBVM") which is regarded as being interested by virtue of section 7(6)(d) of the Companies Act in those shares as EDVM is the discretionary fund manager for PLEI and MCV. As a result of the sale by PLEI and MCV, EDB's deemed interest decreased from 123,085,013 shares in the issuer to 113,085,013 shares in the issuer. This delayed notification which was to have been given within 2 business days of the sale (i.e. 12 August 2004) was inadvertent and an honest omission, and not any attempt to conceal the deemed interest of EDB.
